Charity Gift Aid declaration

This form also acts as your agency agreement with Hub4Stuff to sell goods on your behalf which you may leave with us or which we collect from you.

As such it is a legally binding contract and by completing this form you are confirming that:

You wish Hub4Stuff to act as your agent in selling the goods you have left or will leave with us on your behalf.

You wish Hub4Stuff to keep all net sale proceeds up to £1,000 in any tax year.

We will write to you at the end of each tax year to let you know the cumulative net sales proceeds of your goods.

If the total net sale proceeds in any tax year are below £1,000 you will not be offered your money back before we make a claim for Gift Aid because you agree to donate such money to us.

If the total net sale proceeds exceed £1,000 in any tax year you have the right to receive the amount above £1,000 only; to do so you will need to contact us within 21 days of our writing to you to ask for this money, which we will then pay to you minus an administration fee.

If we do not receive a reply from you within 21 days, we will assume your consent that the net proceeds are to be donated to Hub4Stuff using Gift Aid.

You are confident that you will pay at least £250 in tax in any one tax year and that, if you enter into agency agreements with more than one charity shop and/or make other Gift Aid donations to charities, you will have paid enough Income Tax and/or Capital Gains Tax in that year to cover the cumulative claims for Gift Aid by all the relevant charities.

Any unsold goods may be disposed of by Hub4Stuff at its discretion.

You own all the goods that you are donating, you obtained them in a legal manner and you are not

acting as a business. You agree that Hub4Stuff will not be responsible for any loss or damage to any goods brought to us for sale.
